HOTEL: WESTIN RIVERWALK HOTEL. The Westin is offering government employee conference attendees a special rate of \$117.00 (plus tax) for a single room, \$145.00 (plus tax) for a double room, and \$195.00 (plus tax) single or double junior suite per night with advance reservations. This special room rate is available for October 12th through October 15th should participants wish to arrive the day before the conference begins and/or depart the day after the conference ends. **Valet parking is \$30.00 per day and self-parking is \$15.00 per day.** Reservations may be made by calling 210-224-6500 and asking for the Texas Association of Domestic Relations Office (TADRO) room block. The hotel cut off date for the special TADRO room rate is **SEPTEMBER 20, 2010**. **The room block may sell out quickly so make your reservations early. The “government employee” hotel room rate is only available to government employees. County, state, etc. IDs for government employment verification will be required when checking into the hotel.
